This is a contract between Lynaire Kennels and the pet owner whose signature appears below:

1. Owner agrees to pay the board rate in effect the date of check-in (as posted in office and as indicated on back of contract. Owner agrees to pay any charges for special services requested, and all veterinary costs incurred for the pet while said pet is in the care of the kennel.
2. If the pet becomes ill or if the state of the animals' health otherwise requires professional attention, the kennel, in its sole discretion, may engage the services of a veterinarian and administer requisite medication and care of the pet.
3. Owner agrees that the pet shall not leave the kennel until all charges have been paid to the kennel.
4. Owner certifies by his signature the accuracy of all information given about his pet.
5. Kennel shall exercise reasonable care for the pet while boarding. It is agreed by the owner and kennel that the kennel's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200.00 per animal boarded.
6. Owner agrees to be solely responsible for any and all acts or behavior of said pet while in the care of the kennel.
7. Owner specifically represents he is sole owner of the pet and said pet has not been exposed to rabies or distemper within a 30 day period prior to boarding.
8. **STORM DISCLAIMER:** In case of storm Lynaire Kennels cannot guarantee the safety of owners' pet. Kennel agrees to make every effort possible, without endangering kennel staff, to care for animals entrusted to us. It should be understood by owner that should conditions warrant we too may be forced to evacuate premises. Owner agrees not to hold kennel responsible for injury or loss of pet due to above mentioned fact.
9. This contract contains entire agreement between parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives of the pet owner and the kennel.
10. Any controversy or claim relating to this contract, or the breach thereof, or as the result of claim or controversy involving alleged negligence by any party to this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgement upon the award rendered by the arbitration may be entered in any court having jurisdiction thereof. The arbitrator as part of his award determine an award to the prevailing party the cost of such arbitration and reasonable attorney fees of the prevailing party.
